SATURDAY DECEMBER 4, 2021**

1. Entry forms must be completed and received by the Tournament Secretary along with the entry fee no later than Dec 1, 2021. No walk-ins will be allowed.
2. Participants must be current members of USBC *and* a member of the No Co Women's 200 Club, Avocado 500 Club or the Avocado 600 Club.
3. The official 200, 500 or 600 Club uniforms are **not** required for this tournament. Holiday attire suggested.
4. Tournament shall be 3 games of handicapped singles. Handicap shall be 90% of 220. There will be 2 divisions divided equally after entries close.
5. Entering average shall be in the following order:
  - a. **2019-20 composite average as shown on bowl.com**
  - b. If no composite average, use current average for 21 or more games (must include verification)
  - c. If no current average, entries must bowl scratch per USBC rule 319b.  
USBC rule 319a2, 319c, 319d and 319e **will not apply.** 319a (3) shall apply  
*it is the responsibility of the bowler to verify her average*
6. A bowler arriving after completion of the first frame begins scoring with the frame being bowled.
7. Substitutions will be allowed provided the original entrant notifies the Tournament Secretary one hour before squad time.
8. Prize monies will be returned 100%.
9. Check in table will open at 10:00 a.m., Short meeting before bowling, Practice after meeting.
