LEGISLATIVE COMMITTEE REPORT

Purpose: Reviews proposed legislation, discusses items submitted by staff, other committees, and if needed, may propose legislation or work with another committee to propose necessary legislation.

Any member of USBC has the right to submit an amendment to the USBC Playing Rules or USBC Bylaws. All amendments submitted by a member must be received at USBC Headquarters on or before Sept. 1 preceding the Annual Meeting.

The Legislative Committee reviews all proposed amendments and submits those not deemed unworkable or unenforceable to the USBC Board with a recommendation. The USBC Board votes on a final recommendation to the delegates.

When a proposed amendment is announced to the delegation, there is no need for a second prior to discussion. If there is an amendment to a proposed amendment, that would require a second. It is recommended any amendment to the published proposed amendments be submitted in writing to either the committee chair or a member of the Rules staff prior to the legislative session. When recognized by the chair, any delegate/member may speak for or against the issue on the floor. Each speaker is allowed two minutes, as well as a two-minute rebuttal.

A majority vote is required to adopt any proposed amendment to the Adult Tournament Rules and Adult League Rules. A two-thirds vote is required to adopt proposed amendments to the bylaws. Voting will be conducted by electronic voting device. Instructions will be provided prior to the legislative session.

The Legislative Committee presents the following amendments for consideration by the delegates at the 2020 USBC Annual Meeting.

PRESENT RULE...

USBC Playing Rules Chapter 4, League Rules Rule 105, Absentee and Vacancy Scores

Leagues may adopt rules for absentee or vacancy scores and handicaps to decide league games, subject to the following:

- a. Absentee or vacancy scores may be used only when a legal lineup is present.
- b. Absentee or vacancy scores may not replace scores bowled by an ineligible player.
- c. In a singles league, no vacancy scores shall be used. Absentee scores will not be permitted, unless otherwise provided by league rule.
- d. A vacancy score is to be used when a team has an incomplete roster. Vacancy scores are subject to the following, unless otherwise provided by league rule:
 - 1. Adult leagues:
 - a) The vacancy score shall be 120.
 - b) In handicap leagues, the handicap must be based on the vacancy score used. Handicap shall not be limited.
 - 2. Youth leagues:
 - The vacancy score shall be the average of the lowest average bowler on the opposing team's roster.
 - b) If two or more vacancy scores are required, the average of the next-to-the-lowest bowler on the opposing team's roster shall be used for the second vacancy score.
 - In handicap leagues, the handicap must be based on the vacancy score used. Handicap shall not be limited.
 - d) The vacancy score is used until an individual bowls and establishes a current average.
- e. An absentee score is to be used when a member is absent and a substitute is not obtained. The following provisions apply unless otherwise provided by league rule:
 - 1. The absentee score for each game shall be the absent member's current average less 10 pins. In handicap leagues, the handicap shall be based on the absent member's current average.
 - Teams with additional players on the roster shall use the absentee score of the absent player with the:
 - a) Most games bowled.
 - b) Lowest absentee score when the absentees have the same number of games bowled.
 - c) Next highest number of games bowled when two scores are needed.
 - 3. When a team has an absent member without an established average according to league rules or USBC Rule 118c, a score of 120 will be used. In handicap leagues, the handicap shall be based on the score of 120.

PROPOSAL...

Add a new sentence to Item d to state:

"The vacancy score is used until an individual bowls and establishes a current average."

If adopted, Rule 105 will read:

Leagues may adopt rules for absentee or vacancy scores and handicaps to decide league games, subject to the following:

- a. Absentee or vacancy scores may be used only when a legal lineup is present.
- b. Absentee or vacancy scores may not replace scores bowled by an ineligible player.
- c. In a singles league, no vacancy scores shall be used. Absentee scores will not be permitted, unless otherwise provided by league rule.
- d. A vacancy score is to be used when a team has an incomplete roster. The vacancy score is used until an individual bowls and establishes a current average. Vacancy scores are subject to the following, unless otherwise provided by league rule:



1. Adult leagues:

- a) The vacancy score shall be 120.
- b) In handicap leagues, the handicap must be based on the vacancy score used. Handicap shall not be limited.
- 2. Youth leagues:
 - The vacancy score shall be the average of the lowest average bowler on the opposing team's roster.
 - b) If two or more vacancy scores are required, the average of the next-to-the-lowest bowler on the opposing team's roster shall be used for the second vacancy score.
 - In handicap leagues, the handicap must be based on the vacancy score used. Handicap shall not be limited.
 - d) The vacancy score is used until an individual bowls and establishes a current average.
- e. An absentee score is to be used when a member is absent and a substitute is not obtained. The following provisions apply unless otherwise provided by league rule:
 - 1. The absentee score for each game shall be the absent member's current average less 10 pins. In handicap leagues, the handicap shall be based on the absent member's current average.
 - 2. Teams with additional players on the roster shall use the absentee score of the absent player with the:
 - a) Most games bowled.
 - b) Lowest absentee score when the absentees have the same number of games bowled.
 - c) Next highest number of games bowled when two scores are needed.
 - 3. When a team has an absent member without an established average according to league rules or USBC Rule 118c, a score of 120 will be used. In handicap leagues, the handicap shall be based on the score of 120.

REASON FOR PROPOSAL....

I would like there to be a change to the rule, stating that on the first night of bowling, if a complete lineup is not present, that a vacancy score must be used, not the absentee score of a roster member who is not present.

The reason behind this is that a bowler should not be designated as an official team member in a lineup until they bowl their first ball in the league. By leaving this rule the way it is, a team could "designate" a roster bowler with a very high average, which based on the league's handicap system could benefit them not to have a bowler present. The bowler could then be "replaced" on the roster, with no intent to actually have bowled.

Example: Bowler A is absent the first week, and has a 235 average. The absentee score is 10 off the average, but the league voted in handicap at 80% of 220. Even with the 10 pins off average, the 225 score benefits the team with the absent bowler. I have seen leagues where 200 was the basis for handicap, so this would allow teams to have a "legal lineup" where bowlers could sit out week 1 and give their team a significant advantage.

This should not be a rule that could be changed by a league vote.

REASON FOR REJECTION....

This proposal actually takes the option away from the league to adopt their own rule for this situation and allow for the use of an absentee score for an individual who has met the league's threshold for committing to bowl but is unable to appear the first session. In addition, by defining the spot as a vacancy, there are financial obligations that must be considered that may vary from center to center.

PRESENT RULE...

USBC Playing Rules Chapter 6, Tournament Rules Rule 309a, Cash, Bonds or Merchandise Prizes

The following requirements must be met by tournament management within 30 days after the end of the tournament:

- 1. Distribute all prizes except when USBC Headquarters has authorized delay in payment.
- 2. Submit the following to USBC Headquarters:
 - a. A prize list with the name and score of each prize winner and the prize issued.
 - b. A financial statement listing all prize receipts and disbursements.
 - c. Adult Associate membership and participation fees and USBC Youth membership fees received and a list of those paying such fees.

PROPOSAL...

Add a new paragraph to state:

"Tournament Management must make available a copy of the final prize list and financial statement to any participant who requests it within one year of the end of the tournament."

If adopted, Rule 309a will read:

The following requirements must be met by tournament management within 30 days after the end of the tournament:

- 1. Distribute all prizes except when USBC Headquarters has authorized delay in payment.
- 2. Submit the following to USBC Headquarters:
 - a. A prize list with the name and score of each prize winner and the prize issued.
 - b. A financial statement listing all prize receipts and disbursements.
 - c. Adult Associate membership and participation fees and USBC Youth membership fees received and a list of those paying such fees.

<u>Tournament Management must make available a copy of the final prize list and financial statement to any</u> participant who requests it within one year of the end of the tournament.

REASON FOR PROPOSAL....

A tournament manager has an obligation to provide information about their event to the participants. This proposal clarifies that obligation and adds a reasonable time constraint to the request for such information.

PRESENT RULE...

USBC Playing Rules Chapter 6, Tournament Rules Rule 319c, Average Adjustments (Rerating)

The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.

Unless the tournament rules state otherwise, in a handicap or classified tournament, a bowler who has had his/her average adjusted/rerated in accordance with this rule is required to report all previous assigned average adjustments/rerates, whether the bowler accepted the adjustment/rerate or not, at the time of bowling.

The following information must be submitted prior to participation for possible average adjustment/rerate:

- The name of each tournament in which an average adjustment/rerate was assigned (including date assigned).
- 2. The adjusted/rerated average.

Failure to comply with these provisions is cause for disqualification and forfeiture of entry fees and prize winnings.

PROPOSAL...

Add ".as long as the bowler has attempted future entry for that event" to the end of the first sentence in the first paragraph.

If adopted, Rule 319c will read:

The average of a bowler may be adjusted upward before participation in any event, as long as the bowler has attempted future entry for that event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.

Unless the tournament rules state otherwise, in a handicap or classified tournament, a bowler who has had his/her average adjusted/rerated in accordance with this rule is required to report all previous assigned average adjustments/rerates, whether the bowler accepted the adjustment/rerate or not, at the time of bowling.

The following information must be submitted prior to participation for possible average adjustment/rerate:

- The name of each tournament in which an average adjustment/rerate was assigned (including date assigned).
- 2. The adjusted/rerated average.

Failure to comply with these provisions is cause for disqualification and forfeiture of entry fees and prize winnings.

REASON FOR PROPOSAL....

The Rules Department said prior participation is irrelevant and that any bowler can be rerated by any tournament, even if that bowler did not attempt to sign up or pay for that tournament. Regardless of prior participation, a tournament should not be able to rerate a bowler who has not attempted future entry because that bowler did not agree to their rules and should not be subjected to any actions for something they did not try to have a part in. There is also no pending threat of that bowler participating in that tournament, making the actions unnecessary. Forcing lifetime reporting of a rerate to all future tournaments based on one tournament that you did not attempt to sign up for and may have never previously participated in is absurd and should not be allowed.

The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.

Unless the tournament rules state otherwise, in a handicap or classified tournament, a bowler who has had his/her average adjusted/rerated in accordance with this rule is required to report all previous assigned average adjustments/rerates, whether the bowler accepted the adjustment/rerate or not, at the time of bowling.

Add "If the bowler's average is adjusted upward, the bowler can file a written appeal to USBC." after the first sentence in the first paragraph.

If adopted, Rule 319c will read:

The average of a bowler may be adjusted upward before participation in any event. If the bowler's average is adjusted upward, the bowler can file a written appeal to USBC. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.

Unless the tournament rules state otherwise, in a handicap or classified tournament, a bowler who has had his/her average adjusted/rerated in accordance with this rule is required to report all previous assigned average adjustments/rerates, whether the bowler accepted the adjustment/rerate or not, at the time of bowling.

The following information must be submitted prior to participation for possible average adjustment/rerate:

- 1. The name of each tournament in which an average adjustment/rerate was assigned (including date assigned).
- 2. The adjusted/rerated average.

Failure to comply with these provisions is cause for disqualification and forfeiture of entry fees and prize winnings.

REASON FOR PROPOSAL....

When receiving an average adjustment, the bowler is given the option to appeal by USBC. This notice states: "If you believe your name should not appear on this list (319c Adjustment/Rerate List) you have until (insert date) to respond to this notification with an explanation on why your name should not be included on the list.

Other proposal has shown how a legal error was made by tournament, but that is not being considered because we are not allowed to appeal. This should be considered.



The bowler deserves the opportunity to defend themselves, to be heard, and should have the ability to appeal a right. This should not just apply to protected championships. It should apply to all.

The Legal Committee's stated policy is: Responsible for ensuring the due process for members and athletes and to maintain the integrity of the sport of bowling.

Due process is more than just the ability to participate, it is fair treatment through the system. Fairness is also a part of integrity. Bowlers should be able to compete and also compete on a fair level. Also, since Rule 319c allows tournaments to deny participation, this is a matter of due process so the bowler should be able to appeal.

Tournaments currently have the ability to abuse their power by punishing their enemies with unrealistic rerates even if they violated the rule to do so and the bowler is stuck with the lifetime reporting (essentially using) that rerate everywhere. If the USBC cannot make judgements on fairness are there even limits on what a tournament manager can do? We will elaborate in the next amendment on this but not having the ability to appeal such harsh actions is an injustice and needs to be changed.

Tournament managers have the right to adopt rules/policies that provide protections to the credibility of their events. As these decisions to rerate an individual are influenced in part by the achievements of the player(s) in the event, tournament management generally has sufficient evidence to support their actions.

The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.

Unless the tournament rules state otherwise, in a handicap or classified tournament, a bowler who has had his/her average adjusted/rerated in accordance with this rule is required to report all previous assigned average adjustments/rerates, whether the bowler accepted the adjustment/rerate or not, at the time of bowling.

The following information must be submitted prior to participation for possible average adjustment/rerate:

- 1. The name of each tournament in which an average adjustment/rerate was assigned (including date assigned).

PROPOSAL...

Delete the second, third and fourth paragraphs of the rule.

If adopted, Rule 319c would state:

The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.

REASON FOR PROPOSAL....

Each tournament is different. One tournament should not be the standard for every other tournament. The rerate is only for that tournament and we are not saying to lift or adjust that rerate, we are saying that reporting the rerate elsewhere does not need to be required. We understand that tournaments may want to protect themselves, but they should not have the ability to protect other tournaments, especially for life.

If you had a good tournament or a good game at an easy house tournament (many other bowlers are scoring well over their averages too) that should not impact you for the rest of your life at all other tournaments, especially those that are more difficult like USBC Nationals.

The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded.

Unless the tournament rules state otherwise, in a handicap or classified tournament, a bowler who has had his/her average adjusted/rerated in accordance with this rule is required to report all previous assigned average adjustments/rerates, whether the bowler accepted the adjustment/rerate or not, at the time of bowling for a period of 12 months after the assigned average adjustment/rerate.

The following information must be submitted prior to participation for possible average adjustment/rerate:

- 1. The name of each tournament in which an average adjustment/rerate was assigned (including date assigned).
- 2. The adjusted/rerated average.

Failure to comply with these provisions is cause for disqualification and forfeiture of entry fees and prize winnings.

REASON FOR PROPOSAL....

Each tournament is different. One tournament should not be the standard for every other tournament. The rerate is only for that tournament and we are not saying to lift or adjust that rerate, we are saying that reporting the rerate elsewhere does not need to be required. We understand that tournaments may want to protect themselves, but they should not have the ability to protect other tournaments, especially for life.



If you had a good tournament or a good game at an easy house tournament (many other bowlers are scoring well over their averages too) that should not impact you for the rest of your life at all other tournaments, especially those that are more difficult like USBC Nationals.

Tournament managers should retain the right to require the reporting of a bowler's history for as long a period as they deem necessary to protect the integrity of their competitions. Placing such a time limit on the disclosure of a bowler's history would provide an opportunity for those who seek to withhold prior successes in order to avoid a possible rerate or rejection of their entry.

PRESENT BYLAW...

USBC National Bylaws Article III Membership and Dues Section B, Dues

USBC adult members are required to pay dues to USBC, to local associations, as well as to state associations that assess dues in combined amounts established by USBC.

USBC Youth Standard Membership dues are \$4, state/local association dues are not allowed.

Annual adult standard membership dues are: USBC dues not to exceed \$15. State dues not to exceed \$5. Local dues determined by their membership.

PROPOSAL...

Delete ", as well as to state associations that assess dues" from the first sentence of the first paragraph.

Add a new second sentence to the first paragraph to state: "State associations may assess dues in amounts established by USBC which are optional to the member."

Add "Optional" to the state dues description in the third paragraph.

If adopted, Article III, Sec B will state:

USBC Youth Standard Membership dues are \$4, state/local association dues are not allowed.

Annual adult standard membership dues are: USBC dues not to exceed \$15. Optional State dues not to exceed \$5. Local dues determined by their membership.

REASON FOR PROPOSAL...

Our state is too large for our State Board to manage effectively. Our members feel as if we have taxation without representation.

What does a state board do that your local association can't? When we need to get a ruling, we ask rules directly at the national level. Nothing trickles down from National to the local associations through the state association. Everything gets rolled out at the same time.

If State dues were optional, and a member wanted to participate in the state tournament, the dues can be factored into entry fee. Our constituents would like the option to opt-out of our State Association.
