Chapter One: Introduction

The United States Bowling Congress SMART program began in 1994, offering a centralized location to manage bowling scholarship funds as well as providing USBC members with a resource for inquiries about bowling scholarships. The program disburses youth bowling scholarships in compliance with the United States Olympic Committee (USOC), National Collegiate Athletic Association (NCAA), National Association Intercollegiate Athletics (NAIA) and high schools; and in a manner to protect the amateurism of prospective and current student-athletes.

2005-06: Started working with NCAA, NAIA, and High Schools to ensure eligibility on all levels.

August 2006: Scholarship funds must be deposited with SMART within 30 days after the end of the league/tournament/event in which they were earned, including scholarships for academic or meritorious accomplishments.

August 2008: USBC required all former and awarded (assigned to a person) scholarships issued through an association, including those issued for academic or meritorious accomplishments, to be deposited with SMART.

March 2010: The SMART Bowling Scholarship Funding Corporation was created as an independent entity dedicated to the management, protection, and promotion of the SMART scholarship funds.

January 2021: In 2020, a working group of SMART stakeholders met virtually to discuss the program and opportunities for improvement. Following these discussions, a decision was made to shift the SMART program under the governance of the USBC Board rather than continue under the SMART Corporation. A new governance committee has been formed to oversee the SMART program, with sub-committees of qualified individuals. One sub-committee will be on the finance side to continue ensuring SMART's safeguarding of funds and prudent investment planning. The other sub-committee will be focused on SMART's scholarship use policy.

SMART has a highly conservative investment strategy with the largest portion of earned scholarships placed in safe securities. The remaining assets are invested in a diversified portfolio expected to yield greater returns. Some income is required to cover administrative costs and investment fees, and SMART may allocate a distribution to providers.

SMART oversees investments and sets policy. USBC staff oversees the day-to-day operation of the program.

SMART provides for the management and administration of the program. The management and administration of those funds includes, but is not limited to, the receipt and recording of deposits, all ongoing transactions to the accounts and the approval and disbursement of funds.

Terms and Conditions

The rights and obligations of SMART, USBC, providers and recipients.

Privacy Policy

Describes the type of information we collect and how it can be used.

Participation in SMART

Participation in the program is at no cost to the provider or recipient.

Provider

A person(s) who manages a SMART account and awards scholarship funds.

Recipient

An individual who has scholarships in SMART.

Recipient List

Multiple scholarship recipients in one event.

Unassigned Funds

- * Money submitted by a provider, but not assigned to a scholarship
- * Funds returned from a recipient who did not use their funds within the allotted timeframe
- * Allocation to providers from SMART

Allocation

Based on the overall returns for SMART, earnings may be distributed back to the provider.

SMART Portal

Used to submit information to SMART. The portal is housed on www.smart.bowl.com.

Fiscal Year

Financial fiscal year is January-December.

Provider report fiscal year is August-July.



Chapter Three: Provider

A provider is a person(s) who manages a SMART account and awards scholarship funds. While a provider account can have multiple people, each account must have at least one person.

Accounts are linked to your USBC ID number and multiple people can be on one account.

1. Provider Account

A. By opening, or being added to, an account, you are agreeing to abide by the Terms and Conditions, SMART Policy and Privacy Policy.

B. Type of Account

- * Local/state association
- * Center
- * Tournament
- * League
- * Youth Program
- * Etc.

C. Open an Account

A Provider Account form must be completed and signed.

D. Add a Provider

To add someone to an existing account fill out the <u>Provider Account</u> form. We will need:

- 1) Organization Name
- 2) Account number
- 3) Name and USBC ID of new person
- 4) Email address
- 5) Authorized signature, which could be:
 - * Current provider
 - * Center manager/owner
 - * State/local association officer

E. Remove a Provider

To remove someone from an existing account fill out the <u>Provider Account</u> form. We will need:

- 1) Organization Name
- 2) Account number
- 3) Name and USBC ID of person being removed



- 4) Authorized signature, which could be:
 - * Current provider
 - * Center manager/owner
 - * State/local association officer

F. Merge accounts

To merge accounts, fill out the <u>Provider Account</u> form, we need:

- 1) Organization Name
- 2) Account number for both accounts
- 3) Authorized Signature

2. SMART Portal

The SMART portal is the means used to submit information to SMART, such as:

- * Provider contact information
- * Recipient lists
- * Recipient scholarship amount
- * Payment

Providers are responsible for:

- * Accuracy of the information
- * Maintaining the confidentiality of their account, username and password
- * Keeping contact information current

3. Scholarship Lists

A named list of scholarship recipients.

* Event Name: The name of the league or tournament

* Total Amount: Total scholarship amount
 * Date Event Ended: Last date of league/tournament

* Center Name: Name of the center event was bowled

* Lg/Tourn Cert. #: The events certification number

When entering lists individually a recipient's name, USBCID number and amount is required. When using the bulk upload:

- * The file must be a CSV file with the header row containing:
- * USBC ID
- * First Name
- * Last Name
- * DOB
- * Amount



4. Funds

- A. Scholarships can be paid through the portal using a credit/debit card, or mailing a check to SMART, 621 Six Flags Drive, Arlington, TX 76011.
- B. Funds are to be **RECEIVED** by SMART within 30days:
 - * Of the last date of the league
 - * Of the last date of the tournament
 - * From award date for meritorious awards
- C. If scholarship lists and/or funds are not received by SMART, a complaint could be filed with USBC for possible suspension. (See Item #9 for suspension action; See Chapter Four, Item 11 for action a recipient may take if scholarships are not submitted timely.)
- D. Collected prize/scholarship funds (league or tournament), sponsor contributions, 50/50s, etc., that are designated for a specific event must be used for that event. Unassigned funds cannot be used in place of collected funds but can be used to enhance an event. (See Item #7)

5. Refunds

Once SMART deposits scholarship funds into an account, they are non-refundable.

6. Earnings Allocated to Providers

SMART invests scholarship funds and some of the income earned from the SMART investment is used to cover administrative costs of the program (salaries, supplies, printing, postage, etc.). Income also may be allocated back to the providers.

- * Once a year, in May, SMART may give an allocation to providers with a total balance over \$100, based on the previous calendar year (January-December).
- * The allocation is based on provider account balances as a percentage of the total SMART liability at the end of that fiscal year.
- * Income is defined as the difference between the value of SMART's Cash/ Investments and the amount of SMART's Liabilities as identified in the audited financial statements.

Example:

Cash/Investments \$18,000,000

Total SMART Liability (\$17,500,000) Income \$500,000

The \$500,000 could be allocated to provider accounts and placed in the "Available Unassigned Funds". The allocation is based on provider account balances as a percentage of the total SMART liability, as of December 31.



Example:

A. Provider Account Balance \$175,000B. Total Liability \$17,500,000C. Income for Allocation \$500,000

Allocated to organizations "Available Unassigned Funds"; (A/B*C) = \$5,000

7. Earning Allocation Use

These funds can only be used for scholarships.

SMART may authorize the transfer of unassigned funds to another SMART Provider account, upon written request.

These funds **cannot** be used in place of paid prize/scholarship money.

8. Inactive Provider Account

An account will be closed if it has no:

A. Recipient(s)

B. Activity within five years

A provider account is considered inactive when a deposit or a funded list is not entered into the account in five years.

Activity does not include the return of expired funds from a recipient or school, or earnings allocated to a provider from SMART.

Recipient funds in an inactive account will remain available. Any unassigned funds will be used to fund scholarships.

9. USBC Suspension

SMART will recognize pending and finalized charges against a provider through USBC's due process procedure. If appropriate:

- a. The provider could be removed from the SMART account.
- b. Upon reinstatement by USBC the provider could be given the account back.

10. Disputes

All disputes are handled by SMART and their decision is final. This includes, but is not limited to:

- * Who the provider is on an account?
- * Suspended provider
- * Closed account



Chapter Four: Recipient

A recipient is an individual who has scholarships in SMART. A recipient does not join SMART; he/she automatically becomes a participant in the program when he/she is included in a scholarship list.

1. Recipient

- A. By becoming a scholarship recipient, you are agreeing to the Terms and Conditions, SMART Policy and Privacy Policy.
- B. An account is opened in the name of the recipient as soon as a funded scholarship is received. The amount of the scholarship is shown in points vs. dollars. (See Item #3)

2. SMART Portal

The SMART Portal is the means used to submit information to SMART, such as:

- * Recipient contact information
- * Scholarships received from providers
- Request funds for education (See Item #7)

Recipients are responsible for:

- * Accuracy of the information
- * Maintaining the confidentiality of their account, username and password
- * Keeping contact information current

3. Points vs. Dollars

- * One point equals \$5.00.
- * Points less than \$5 are rounded down.

Example: \$34 will show as 6 points; however, full funds are in the account. When a recipient requests funds, the exact dollar amount is shown and can be used.

4. Educational Institutions

Where recipients can use scholarship funds:

- * Universities
- * Colleges
- Business schools
- * Technical schools
- Trade schools
- Vocational schools.
- Continued education for mentally challenged individuals will be case handled.



5. Use of Funds

Can only be used after high school graduation.

A. Tuition

Funds will go directly to the school for secondary education courses.

B. Necessary Purchases

Funds will go directly to the school for purchases through the campus bookstore. Off campus purchases can be reimbursed, with appropriate paperwork.

- 1) Textbooks
- 2) Required class supplies
- 3) Equipment necessary for the completion of a course or program, which may be a computer. A computer is limited to one every two years.

NOTE: For reimbursements for off-campus housing, and student loan payments go to smart.bowl.com and fill out the form. Once the form is filled out and necessary documentation is submitted, you will be notified if/when we approve the request.

C. Housing/Meal Plans

- 1) On-campus meal plans (Funds sent to the school)
- 2) On-campus housing plans (Funds sent to the school)
- 3) Off-campus housing (Funds sent to the school, or provider)

D. Student Loan

Fund will be paid directly to the loan company.

E. Items SMART funds cannot be used for, but not limited to:

- * Private grade or high school
- * Grade/High School classes, supplies, etc.
- College classes taken while in high school.
- * Renting from parent, relative, friend, etc.
- * Deposit
- * Enrollment Application
- * Test Fees (Exam Fees)
- * Certification Fees
- * Coaching
- * Bowling Lessons
- * Bowling Fees
- * Bowling Equipment



6. Michigan Students - Requesting Funds

Michigan students are required to meet additional standards as defined by The Michigan Bowling Scholarship Fund ("MBSF") and approved by the Michigan High School Athletic Association, before a scholarship can be used.

The state of Michigan has a Gatekeeper, Michigan's approval process for scholarships. The SMART system cannot determine when/where a scholarship was derived and all accounts for bowlers with a Michigan address are subject to the Gatekeeper.

After high school graduation, the Gatekeeper will need:

- * A copy of your high school transcript showing a GPA of at least 2.0
- Michigan Bowling Scholarship Fund Application/Worksheet form, found <u>here</u>.

The form can be emailed to either:

Or, mail the documents as stated on the form.

Once the proper documentation is received and approved you will be notified directly by the Gatekeeper.

7. Disbursement (Payment to School)

- A. Funds must be requested through the SMART Portal
- B. Will be paid directly to the secondary educational institution
- C. Can be used for:
 - 1) A current or upcoming semester
 - 2) Former semester upon proof the bill is still outstanding to the school.

8. Extension

SMART does not allow extensions.

9. Transferable

Scholarship funds are not transferable; only the original recipient may use the funds.

10. Provider does not put funds in SMART

If it has been more than 60 days from the end of the league/tournament or date it was awarded (if meritorious), the recipient must contact the provider, in writing, giving the provider a deadline (such as 15 days) to submit funds to SMART.



If funds are not received, then all documentation can be sent to smart@bowl.com we will need:

- * Name of competition or entity that awarded the scholarship
- Center in which league/tournament was bowled
- * Name of person responsible
- * Copy of certificates, letter of congratulations, etc.
- * Copy of all written correspondence with person responsible

11. USBC Suspension

A. Recipient:

SMART will recognize pending and finalized charges against a recipient through USBC's due process procedure. A recipient suspended from USBC will have their scholarships available, unless, the charges are related to the fraudulent use of their scholarships.

B. **Provider:** Charges may be filed against a provider for misuse of scholarship funds when scholarship funds are not submitted to a recipient's account within 30 days. The complaint would be filed with the USBC Rules department at rules@bowl.com.

12. Funds Expire

Scholarship funds expire:

- A. Eight years from high school graduation date
- B. If awarded after high school graduation, eight years from award date.
- C. **Military:** If approved by SMART, eight years from high school graduation, plus the number of years in the first enlistment.

Example: If the first enlistment is four years, the funds would expire 12 years after high school graduation.

In order to have the first enlistment years added, enlistment date must be reported prior to expiration of funds (Eight years from high school graduation/award date).

Funds expire at the end of the fiscal year (December 31) and funds not used by a recipient will be returned to the provider account.

13. Disputes

If scholarship funds are not available for any reason or cause, other than as a result of the willful misconduct of SMART, neither the provider nor the SMART Corporation shall be liable to a recipient for such funds or any resulting damages.

All disputes are handled by SMART and their decision is final. This includes, but is not limited to, an early expiration of a recipient account.



14. Taxes Implications

Use of these scholarship funds may have certain tax implications. Please read IRS Tax Publication 970 (*Tax Benefits for Education*), contact the IRS or consult a financial advisor for further information.
