# TOURNAMENT RULES: (This is a Qualifying Tournament to the California State Helen Duval Veterans Tournament which will be held on Saturday & Sunday, November 5 & 6, 2022 at Bowlero – San Marcos, 945 San Marcos BLVD, San Marcos, CA 92069; 760-744-7000.

- 1. **Eligible:** All current USBC members are eligible to participate. However, **ONLY** North County USBC members may qualify and represent the association at the Helen Duval Tournament.
  - a. Participants are required to show current USBC membership cards at time of check-in.
  - b. Any person who bowls under an assumed name, under the name of another person scheduled to bowl in the tournament, or who is under suspension from USBC membership shall be disqualified. The individual shall forfeit his/her entry fee, all prize moneys, and be subject to suspension from USBC membership.
- 2. **Entry Fee:** Adults \$30.00 per person (Lineage \$11.25, BVL \$17.75, Exp. \$1.00); \$25.00 for <u>re-entry</u> (Lineage \$11.25, BVL \$13.75). Youth may ONLY participate in the Youth Division. Re-entries may also pay additional \$5.00 for Scholarship Fund.
- 3. **Optional HDCP Prize Fund:** \$5.00 will be returned 100% at least one (1) place for every ten (10) entries with a handicap of 90% of 210. Bowlers may only place once in prize fund. Checks will be mailed to the adult winners. In lieu of prize fund, youth bowler winners will receive scholarships to be place into the S.M.A.R.T. program.
- 4. **Tournament Format:** Three (3) games singles scratch by division, certified by USBC:
  - a. Any group wishing to bowl together please send entry forms on together in same envelope or check-in together.
  - b. See tournament divisions on front page.
  - c. All ties will be decided by a one (1) game roll off.
- 5. Entry Closing Date: November 6, 2022, 1:00 PM or when the last squad is filled. Walk-in entries accepted.
- 6. Averages:
  - a. Highest composite average for the 2021-2022, 2020-2021 or 2019-2020 seasons.
  - b. If a certified "Sport" league average is the bowler's only average, then it will be adjusted per the chart in the USBC rulebook to determine the correct entering average. USBC rule 201a-c will apply.
  - c. <u>Bowlers are responsible for verifying their own average</u>. Any falsification of the highest known average will result in immediate and final disqualification.
  - d. Bowlers without a verifiable average will be entered into the Classic Divisions and cannot qualify for the <u>Helen Duval Veterans Tournament (CAUSBC State Finals).</u>
  - e. USBC rules 319a-e will be in effect.
- 7. **Late:** Any bowler arriving late will start game in the frame being bowled and will receive zero for any frames missed. No frames can be made up.
- 8. **Equipment failure:** As per USBC Rule 321 If equipment failure on a pair of lanes would delay the progress of the series, a tournament official can authorize the completion of a game and series on another pair of certified lanes. The interrupted game and series must be resumed from the point of interruption. No practice will be allowed after being moved.
- 9. In the event of a tie score in any division a one game roll off must take place to determine the association representative. Bowler may only represent one (1) association at the State finals.

### Adults:

First Entry: \$30.00 (Lineage - \$11.25, BVL Donation - \$17.75, Expense - \$1.00)

First Entry with Optional Prize Fund: \$35.00 (Same as above with additional \$5.00 Prize Fund)

Subsequent Entries: \$25.00 (Lineage - \$11.25, BVL Donation \$13.75)

Subsequent Entries with Optional Prize Fund: \$30.00 (Same as above with additional \$5.00 Prize Fund)

#### Youth:

First Entry: \$30.00 (Lineage - \$11.25, BVL Donation \$17.75, Expenses \$1.00)

First Entry with Optional Scholarship Fund: \$35.00 (Same as above with additional \$5.00 Prize Fund)

Subsequent Entries: \$25.00 (Lineage - \$11.25, BVL Donation \$13.75)

Subsequent Entries with Optional Scholarship Fund: \$25.00 (Same as above with additional \$5.00 Scholarship Fund)
